On 10/12/64 LA 4335-PC advised that he considers JOHN ROSELLI to be a member of the "organization" (Mafia) and to be a very cunning and important individual in this group. He believes that ROSELLI represents the interests of FRANK COSTELLO (notorious New York hoodlum figure) in the Los Angeles and Las Vegas areas. This informant will be reinterviewed, and it is believed that more detailed information concerning ROSELLI's activities will be obtained.

The New York Office advised that RONALD R. HOWARD, friend and associate of ROSELLI, returned to the Waldorf-Astoria Hotel on 10/12/64 and is awaiting the arrival of an individual believed to be TED KRIEGER. (It is noted that HOWARD was recently a guest at this hotel with KRIEGER, who is from California). HOWARD expressed an interest in buying or renting a suite at the hotel and is also interested in buying a seat on the New York Stock Exchange. He is presently occupying Suite 1585 at the Waldorf-Astoria. LA 4268-C has furnished information in the recent past indicating that HOWARD, GOODWIN KNIGHT, ex governor of California and others were planning to go into the stock brokerage business.
