Investigation concerning AL BORODKIN has revealed that he is the son of HERBERT BORODKIN, a retired musician, who resides at 1533 Merion Way, Building 26K, Leisure World, Seal Beach, California. HERBERT BORODKIN moved to California several years ago from Brooklyn, New York. BORODKIN has been a small investor utilizing the services of Walston and Company since he arrived in California.

J.R. SCANLIN, Commission Man for Walston and Company, advised that HERBERT BORODKIN has a son, AL, who was the owner of a TV or movie production company and sometime within thepast year he sold out to a major production company; that in May, 1963, HERBERT BORODKIN purchased 300 shares of stock in the Peel-Elder Company and told SCANLIN that his son, AL, had purchased 10,000 shares of this same stock, and AL was with a group that included ROCKY MARCIANO, former heavyweight boxer. Peel-Elder Company is a Canadian corporation whose main interests are gold mines and building developments.

According to LA 4268-C, AL BORODKIN was associated with the Harwyn Publishing Company. Information appearing in the Wall Street Journal, issue of 2/5/62, sets forth that Harwyn Publishing Company publishes and distributes illustrated encyclopedic works for children, and through Regal Advertising Associates Corporation operates an advertising agency specializing in the sale of TV and radio advertising spot time.
