LV 10-C furnished information that ROSSELLI checked into the Desert Inn Hotel, Las Vegas, Nevada, on 9/24/64, alone and indicated that he would remain until 10/4/64. The same informant advised on 9/29/64 that ROSSELLI was registered at this hotel and assigned to room 2503 and that on 9/27/64 he placed a long distance telephone call to Chicago, Illinois, telephone number 943-1155, and talked for five minutes. It is noted that this is the number of LOUIS J. LEDERER who is a close friend and former business associate of ROSSELLI.

On 9/28/64 SHARON SHERMAN, Switchboard Operator, Glen Towers Apartments, advised that both ROSSELLI and his girl friend, KATHY HORDEN, have been gone for the past several days and she had no information as to where they were. SHERMAN said that on 9/28/64 a Mr. HOWARD called for ROSSELLI from New York City and gave his number as EL 5-3000, Room 38E. It was believed that this was RON HOWARD, a stock broker for Hayden-Stone, Inc., Beverly Hills, California, who is a friend of ROSSELLI. The New York Office advised on 10/1/64 that HOWARD was in fact RON HOWARD who was registered at the Waldorf Astoria Hotel and left the hotel on 9/30/64 leaving no forwarding address. New York will obtain HOWARD's long distance telephone calls made from the hotel.

On 10/1/64 information was obtained from the Los Angeles Police Department that ROSSELLI arrived in Los Angeles from Las Vegas at 7:30 p.m. on 9/30/64 via TWA flight number 121.
