recovered and fled the country. The assassination was allegedly at PROFACI's orders.

The 1937 Newark City Directory lists a DOMENICO D'AMICO as Director of the D'Amico Macaroni Company, 34 Drift Street, Newark. GASPARE is listed as President of this company.

Newark files also show that on 1/24/58, Lt. LEON NEIDORF made available Essex County Prosecutor's Office murder files, number 247, 248 and 249. These files showed that VINCENZO TROIA, his stepson, JOSEPH TROIA, and FRANK LONGO, of 109 North 15th Street, Bloomfield, New Jersey, were murdered at 10:57 AM, 8/22/35, in a candy store located at 317 South 6th Street, Newark, N. J.

An article appearing in the "Newark Evening News" on 8/23/35 noted that VINCENZO TROIA was reported to be the operator of the Two Eagles Italian lottery, one of four such lotteries operated in the City of Newark. The bodies of VINCENZO and JOSEPH TROIA were claimed by Brooklyn undertaker, CHARLES C. CATALANO, and were shipped to Italy for burial.

The above information is submitted to assist in the evaluation of that furnished by NY T-2 in referenced report, 7/1/63. Although informant's information concerning the fact that D'AMICO and the TROIAS met violent deaths is substantially correct, it does not appear that TROIA could have been responsible for D'AMICO's death since TROIA was himself killed eighteen months earlier.

Cases have been opened to identify and determine the activities of Dr. PHILIP NOTO, DANNY NOTO, FRETCHIE (LNU), and HAPPY (LNU) (believed to be JOSEPH BELLINO), all reported by NK 2319-C* to be members or potential members of Cosa Nostra.

Synopsis:

A confidential source advised that RAYMOND PATRIARCA has made plans to "get" an individual whom source believes to be JOSEPH VALACHI. PATRIARCA reportedly contacted source to enlist his aid in providing unknown persons from Chicago and Detroit with transportation. However, there have been no further developments to date. LOUIS H. FERRINI, inmate, New Jersey State Prison, Trenton, N. J., interviewed 9/10/63 and amplified previous information regarding his witnessing a secret initiation at New Jersey State Prison in about 1956. Participants in this ceremony identified.

DETAILS:

On August 20, 1963, NK T-1 advised that during the week end of August 17-19, 1963, he had been in Providence, Rhode Island, where GUIDO ZARLANGA introduced him to RAYMOND PATRIARCA. The informant has been in contact with ZARLANGA several times recently and they have discussed various criminal schemes. On this occasion, according to the informant, PATRIARCA told of plans to "get the guy" before he goes to court to testify. The informant understood the reference to be to JOSEPH VALACHI, who has made public disclosures about Cosa Nostra. PATRIARCA said that the job was to be done by persons unknown to NK T-1, two from Chicago and two from Detroit. The informant was instructed to return to New Jersey and wait until he was told when and where to pick up these persons and provide them with transportation.

On August 21, 1963, NK T-1 advised he had had a telephone call from PATRIARCA who told him to "be ready," and that the two guys from Chicago were in Long Branch, New Jersey. The informant assumed that these persons knew how to get in touch with him but had not done so as yet. At this time, the informant reported that he had no details how the presumed assassination would be accomplished nor did he know the identity of any of the individuals who would participate. His role as he saw it was to act as a driver only.

On September 4 and 5, 1963, NK T-1 advised that although he was under the definite impression that it was PATRIARCA's intention to "take care" of JOSEPH VALACHI, he has heard nothing further from him and now assumes that PATRIARCA has decided that the plan is not feasible at this time.

Informant was contacted on September 9, 12 and 20, 1963, and in each instance stated that he has heard nothing from PATRIARCA nor from anyone else on this matter. NK T-1 gave his assurance that he would promptly report further developments.
