One NORMAN HOFFA, 2021 Spring Garden Street, Philadelphia, PHPD #319428, DOB 11/22/22, Charleston, West Virginia, was arrested on 5/7/59 at 1638 Market Street, Philadelphia, Pa., for soliciting to commit sodomy; disposition - committed to Philadelphia General Hospital.

The Bell Telephone Company of Pennsylvania crisscross directory reflects telephone number HO 2-8767 is listed to Cabana Steaks and DOMINIC VINCIGUERRA, 2152 South Dorrance Street, Philadelphia, Pa. There is no listing for NORMAN E. HOFF.

VINCIGUERRA) operates YOYO's Bar, 15th and Dickinson Streets, Philadelphia, Pa. On 10/4/63 PH 540-C advised that "YOYO" operates Cabana Steaks, 2152 South Dorrance Street, Philadelphia, Pa., and YOYO's Bar, 15th and Dickinson Streets, Philadelphia. According to this informant, a "queer" by the name of NORMAN works for "YOYO" at Cabana Steaks, 2152 South Dorrance Street, Philadelphia.

On 10/4/63 PAUL RUST, Radio Station WIP, Philadelphia, advised that WIP has not had any additional contacts from anonymous letter writer or anonymous telephone caller. RUST is of the opinion that the anonymous telephone call he received on 9/28/63 was a "prank" and not made by same person who wrote the anonymous letter.

It appears that the presence of the vehicle bearing Pennsylvania license 704-65P at Independence Square at 5:30 a.m., 10/1/63, had no bearing on instant matter. This area is known to have some "queer" activity, which would account for this vehicle being in the area.

RUST of WIP will advise this office if any additional contacts are made at WIP. The Bureau will be advised of any additional developments if and when they occur.
