Doctor ARISTIDE MANOPULO, Central Bureau, Criminal Bureau, Italian National Police, Rome, Italy, was furnished the information set out in referenced Bureau cable on 10/4/63.

Doctor MANOPULO understands that verbatim transcripts of the U. S. Senate Sub-Committee concerning this matter will not be available for some three months. He requested, however, that this office explore the possibility of obtaining any public source or releaseable Bureau summaries of the testimony of JOSEPH M. VALACHI to date.

The Italian public at large, and the Italian National Police in particular, are closely following Italian public news media reports on VALACHI'S testimony, but these reports are doubtless briefer and much less comprehensive than press coverage afforded the testimony in the U.S., and particularly Washington, D.C., papers.

Doctor MANOPULO is well aware of the intense interest of the Bureau in this matter and he has made known to the Rome Office that the Italian National Police and Italian Parliament are also intensely interested. He has stated that he will promptly make available, in detail, any pertinent information developed. He points out, however, that it is only the U. S. authorities who have, to date, managed to break the curtain of silence surrounding key personalities in this matter in an effective fashion.
