On 10/21/64, informant advised that he has been making considerable progress in resolving his financial difficulty. He stated that he has recently obtained substantial settlements in three injury cases and reduced his debts by approximately fifty per cent. Informant advised the only outstanding obligation he has concerning mortgage money is a \$10,000 advance fee paid to him.

Re: International Brotherhood of
Teamsters Loans

Source advised that on 10/17/64, he attended a cocktail party prior to a dinner for JOHN O'ROURKE, President of Teamsters Joint Council 16, New York. During this party, he was in conversation with FRANK DIOGUARDI, brother of JOHN DIOGUARDI and MURRAY W. MILLER aka Dusty Miller, Tenth Vice President, IBT. During their conversation, they discussed the possibility of obtaining Teamster loans. FRANK DIOGUARDI told the informant that he had been told by ABE GORDON, notorious labor racketeer, that (FNU) MATHESON (ph), an attorney from Detroit, Michigan, who is an employer-trustee of the Central States Teamsters Pension Fund, is "one of us" and is "on the take". Informant advised that this discussion took place in MILLER's presence, but MILLER did not comment on DIOGUARDI's statement. Informant stated that MATHESON was not further discussed and he does not have any further information concerning this individual.
