FOR INFORMATION RECEIVING OFFICES ROSSELLI 141 MAY 16 1966 CONTACTED FIVE FIVE LAST PURSUANT APPROACH SET OUT LOS ANGELES AIRTEL TO BUREAU FOUR FIFTEEN LAST. ROSSELLI DID NOT APPEAR AT MEETING PLACE ON FIVE NINE, BUT HIS ATTORNEY, JAMES CANTILLON, CONTACTED LOS ANGELES OFFICE THAT DATE AND WANTED INFORMATION REGARDING SUBJECT MATTER ABOUTS HIGH FBI WANTED INTERVIEW ROSSELLI. CANTILLON SAID WOULD DETERMINE IF ROSSELLI WOULD TALK TO AGENTS ALONE AND WOULD THEN RECONTACT LOS ANGELES OFFICE.
