There are enclosed herewith for the Bureau six copies and one copy for Boston of a letterhead memorandum setting forth additional questions to be presented to TANCREDI and PARIGI TORTORA. In some instances additional facts are set out to assist the Agent conducting the interview.

On 5/12/66 Agents of the Los Angeles Office interviewed LA 4448-C-TE in an ostensibly normal interview concerning JOHN ROSELLI's true identity; namely, FILIPO SACCO. LA 4448-C-TE denied any knowledge that ROSELLI's true name was FILIPO SACCO.

On 5/17/66 LA 4448-C-TE met with JOHN ROSELLI in Los Angeles. This meeting was initiated by LA 4448-C-TE. He told ROSELLI that he had been interviewed by FBI Agents regarding ROSELLI's true identity. ROSELLI told source that he was not worried about this. ROSELLI said it was (and he then
