## JOHN ROSELLI, aka

Moro reportedly was highly regarded by Mrs. Rosen-Caonts, and on occasion she took care of him when he was suffering from bronchial hemorrhages.

Moro married Irene, the daughter of Mrs. Rosen-Caonts. Moro and Irene were divorced in the late 1940's. Shortly thereafter their divorce, Irene returned to Novia Scotia and reportedly was shot and killed in "cold blood" and her murderer was never apprehended.

Mrs. Rosen-Caonts might have met John Roselli through Michael Moro, and she might have known Roselli as Filippo Sacco.

It is requested the following investigation be conducted:

- 1. That Roselli's fingerprints be searched through the Central Fingerprint files of the Royal Canadian Mounted Police (RCMP) and also search RCMP's records for the names John Roselli, John Rosselli, Filippo, Philippo, or Philip Sacco.
- 2. Exhibit photographs of Roselli to Mrs. M. "Rose," or "Rosie" Rosen-Caonts and Enterview her and obtain all information she might have concerning John Roselli or Filippo Sacco whom she might have met through Michael Moro.
- 3. Obtain from Mrs. Rosen-Caonts and details she can furnish regarding Michael Moro's activities in Novia Scotia and elsewhere including specific dates whenever possible.
- 4. Determine if she knows other persons who might know Roselli as Filippo Sacco and who could possibly furnish information concerning his activities. Possibly some associate of Moro would know this.
