Re report of SA JOHN F. KEHOE, JR. dated 7/29/66, at Boston, Massachusetts and Los Angeles airtel to Bureau dated 6/16/66.

The purpose of the investigation in this case, since the time information was received that ROSELLI's true name is FILIPPO SACCO, has been (1) to endeavor to locate some criminal activity on the part of ROSELLI which caused him to change his name and for which he could possibly still be charged. To date, no such criminal activity has been uncovered. (2) to develop information proving that JOHN ROSELLI is, in fact, FILIPPO SACCO.

Only two people, namely LA 4448-C-TE and TANCREDI TORTORA, who resides in Italy, have advised that they know JOHN ROSELLI's true name is FILIPPO SACCO. Neither of these
