Re New York letter to Los Angeles dated 8/22/66, setting forth information concerning JOHN ROSELLI by NY 1839-C-TE.

For more than 40 years ROSELLI has claimed he is from Chicago and in 1936 filed a falsified delayed birth certificate claiming birth in Chicago. In fact, he was born in Italy; his true name is FILIPPO SACCO and he spent his childhood in Boston, Massachusetts.

The "uncle who was an old time Mafiosa" is no doubt ANTHONY D'ACUNTO, who died in Los Angeles in 1930. D'ACUNTO was from New York and lived in Chicago in the early 1900's. He was a bootlegger in Los Angeles when he and ROSELLI became acquainted. ROSELLI claimed D'ACUNTO as an uncle, but there is no relationship between the two.

The movie starlet who source stated corresponded with ROSELLI in Atlanta Penitentiary is no doubt BERNICE ANN FRANK, who also visited ROSELLI in prison. Her brother

When and where did he first meet ROSELLI?

Who introduced them?

What was ROSELLI's business at this time?

Why was source introduced to JOHN ROSELLI?

Exhibit photographs of JOHN ROSELLI taken in 1925 and in 1930, which New York has, to source.

Did source ever hear that JOHN ROSELLI was not his true name?

Did he ever hear that JOHN ROSELLI was from Boston and his true name is FILIPPO SACCO?

Obtain in detail source's association with ROSELLI with specific dates and places where possible.

Names of other associates of JOHN ROSELLI, especially in New York, Boston and east coast area.

Does source know of any crimes committed by ROSELLI when he was a young man in his teens?

Furnish the name of NY 1839-C-TE as Los Angeles may have information in their files concerning him.
