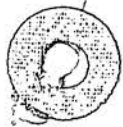

Attached is a letterhead memorandum concerning the recovery of some slot machines by a Deputy Sheriff in Jefferson Parish from the home of another Jefferson Parish Deputy Sheriff, which has resulted in considerable publicity in the New Orleans newspapers since 2/3/61. This is being forwarded to the Bureau inasmuch as publicity in the newspapers has indicated that the Jefferson Parish Crime Commission has directed a wire to the Attorney General requesting a Federal investigation in Jefferson Parish.

The [redacted] mentioned in the attached memorandum is a PCI of the New Orleans Office, but agents handling him have been unable to contact him since this matter came to light. [redacted] will be located and interviewed concerning this matter and further memoranda will be submitted.
