It will be noted that recently, the Phoenix Division developed an informant, PX 696-C, who is very close to the activities and associates of WILLIAM S. BONANNO, son of JOSEPH BONANNO. This live informant at this time appears to be in the best position of anyone to possibly obtain information concerning JOSEPH BONANNO's activities, inasmuch as past investigation has established that JOSEPH BONANNO is extremely secretive and only through his son, who is at times loquacious is much if any information received concerning this subject. There is also being used as an informant in the Phoenix Division the personal physician of JOSEPH BONANNO, who is carried as a Potential Criminal Informant, [REDACTED] M.D. Phoenix Division

has in the past and is still utilizing his services, a real estate investment broker, who is carried as a Potential Criminal Informant, [redacted] who has in the past handled some real estate transactions for JOSEPH BONANNO. During the recent past, however, this informant has been unable to furnish any information of value concerning this subject.

During the period covered by this report, the Phoenix Division utilized highly confidential sources in the residence and automobile owned by the subject, but no information of value was received from either of these sources concerning any activities or connections of JOSEPH BONANNO, with the "Commission". As has been previously stated, investigation has established that JOSEPH BONANNO does nothing in Arizona except reside in Tucson in the role of a wealthy retired gentleman. Through the investigation concerning his activities, there has never been developed in the Phoenix Division or by other divisions of the Bureau any information to indicate that BONANNO has any "commission" activity whatever going in Arizona..
