Rebulet, 8/8/58, requesting results of investigation conducted by nuxiliary offices to date regarding the elleged whereabouts of GAERIEL MANUARING.

The Cleveland Office on 3/23/58 advised that inquiries among law enforcement officers, Norren, Chio, PD, and Trumbull County Sheriff's Office, Harren, indicate that CHARLES, HIKE and BENJAMIN IMBURGIA, local hoodiums, have not left tarren recently and are not known to own a yacht. The Cleveland Office pointed out that the law enforcement officers contacted have made inquiries of their informants concerning the allegation that MANNARING could be staying with the IMBURGIAS, with unproductive results.
