ReWFOlet dated 8/31/66, captioned "ANTI - FIDEL CASTRO ACTIVITIES, IS - CUBA", indicating meeting of JURE "Directors" to take place in San Juan, Puerto Rico, probably during week 9/3 - 10/66.

On 9/13/66, PEDRO ENTENZA, PSI (protected by request - reliable) advised JURE meeting postponed until November, 1966, probably about Thanksgiving Day (11/24/66). All preparations for meeting originally scheduled 9/3 - 10/66 stopped because of airlines strike. Meeting still planned to be held in San Juan, Puerto Rico.

Recipient offices previously requested to alert informants and sources (reWFOlet) to report on meeting.

ANTI - FIDEL CASTRO ACTIVITIES
INTERNAL SECURITY - CUBA

WF T-1, on July 26, 1966, reported learning that one Pedro Entenza had been in touch with [Vasco Leitao da Cunha, the Brazilian Ambassador] in Washington, D.C., to discuss one Mr. Ray, not further identified.

The ["Diplomatic List"] dated [May] 1966, which is published by the [United States Department of State (USDS)], refers to [His Excellency Vasco Leitao da Cunha] as [Ambassador] at the Embassy of Brazil in Washington, D.C.

On August 12, 1966, WF T-2 identified Pedro Entenza as "Undersecretary of Foreign Relations" in the Washington, D.C., area for the Junta Revolucionaria Cubana (JURE) an anti - Castro organization headed by Manolo Ray in Puerto Rico, a former Cuban Government official who defected from the Castro Regime.

[WF T-2] having been aware of Entenza's contact with [the Brazilian Ambassador], was in a position to report as follows:

Entenza received a letter from Manolo Ray indicating that a meeting of about ten or twelve JURE "Directors" will take place in San Juan, Puerto Rico, probably during the week of September 3, 1966, through September 10, 1966. In this letter, Ray commented that "things are going well inside Cuba." In addition, Ray asked to be remembered to Vasco da Cunha.

WF T-2 stated that the agenda for the JURE Meeting has not been formulated. Discussions are planned and guest speakers will be invited to lecture.

WF T-2 noted that Entenza had contacted [Vasco da Cunha] (S) in the past. Entenza met [Vasco da Cunha] (S) through Manolo Ray. Ray is a long-time friend of [Vasco da Cunha] (S). They first met in Cuba when Ray was a Cuban Government official and [Vasco da Cunha] (S) was the Brazilian Ambassador to Cuba (S).

(S) WF T-2 stated that Entenza was aware of [Vasco da Cunha] (S)'s anticipated travel to [Brazil] (S) on vacation and, in view of this, arranged to visit [Vasco da Cunha] (S) prior to his departure from the United States (S).

WF T-2 noted that [Vasco da Cunha] (S) is anti - Castro and that all Cuban exile groups would like to have his support for their respective organizations. WF T-2 feels that [Vasco da Cunha] (S) would never take any action in respect to recognition of a Cuban Government in exile unless Latin American countries were unanimous in such action and provided such action was coordinated by the United States (S).

[Vasco da Cunha] (S) was described by WF T-2 as a very friendly and gracious person who is entirely sympathetic with the Cuban exiles. It was noted that [Vasco da Cunha] (S) does not favor any one anti - Castro group over another group. Most exile groups would like to feel that [Vasco] (S) supports their particular group. (S)
