action. Although the trial in the case captioned, "STUART SUTOR; etal, ITSP; TGP; FFA; NM; CONSPIRACY, " involving several MANNARINO associates, resulted in convictions in the U. S. District Court, Western District of Pennsylvania, Pittsburgh, in February, 1960, new information has come to the attention of the Pittsburgh Office which involves four additional subjects and which will require extensive, concentrated investigation. Also, new information has been received which will require investigation in the case captioned, "BERNARD J. EZHAYA, etal, ITSP - MT." Investigation of the foregoing matters is for all practical purposes investigation of the MANNARINO organization. Coverage on the MANNARINO organization's activities in the New Kensington, Pa., area will be maintained by contact with informants and PCIs.
