With regard to the IRS investigation of the MANNARINO-owned Nu Ken Novelty Company, New Kensington, Pa., operation in pinball machines, it is noted that on 3/15/61, FO 612-C advised SA THOMAS G. FORSYTH, III as follows:

Since early 1960 or late 1959, he has not been interviewed by any investigator from IRS, Pittsburgh, even though he has two Nu Ken Novelty Company machines in his numbers writing establishment in New Kensington. However, he has heard that such interviews are going on in the area currently, and instructions have come through the "grapevine" not to furnish any positive information upon interview but to deny any suggestion that the gross take from the machines is not being accurately reported. Since TONY WARDCLIP and JOE CALCAGNO stopped collecting from the machines for the company on a regular basis, various individuals have been making the collections. He will attempt to ascertain the identities of these collectors and furnish them to SA FORSYTH.

He will also attempt to furnish more information concerning the operation of the Empire Treasury Lottery ticket in the New Kensington area.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
