On 3/23/61, PG 615-C advised SA THOMAS G. FORSYTH, III as follows:

GABRIEL MANNARINO has returned to his home from his vacation in Florida. Since his return, rumors among gamblers in New Kensington, Pa., are circulating to the effect that GABRIEL MANNARINO plans a big "shake-up" in his organization. Informant interprets this to mean that changes of assignment will take place in connection with MANNARINO's various illegal enterprises, and informant will be alert for any such changes.

On 3/23/61, WILLIAM MEREDITH, Special Agent, Bell Telephone Company, Pittsburgh (protect per request), furnished IC GEORGE C. DIPPOLD with a list of toll telephone calls from Emerson 2-3858, subscribed by A. J. "JACK" WISE, JR., 811 South Negley Avenue, Pittsburgh. WISE is the "front man" being used by SAMUEL MANNARINO in the operation of the Ken Oil and Gas Company, which locates, develops and exploits natural gas and oil wells in Western Pennsylvania.
