On 4/24/61, the neighborhood source in the vicinity of the MANNARINO cottage on RD #3, Leechburg, Pa., advised that little activity was observed at the cottage from 4/21-24/61. The caretaker and the dogs were observed from time to time but no visitors showed up, possibly due to the almost incessant rainfall during the week end.

On 4/24/61, PCI [redacted] New Kensington, Pa., OTHER 4 advised that he had received information that GABRIEL MANNARINO is the owner of a trucking company by the name of MANNOR Real Estate and Trucking, Buckhorn Hotel, Marionville, Pa. He said this trucking company is jokingly referred to as B & G Trucking Company, the B & G standing for Bullets and Grenades.
