*w* On 5/3/61, PETER DOWNEY, 1500 Lincoln Ave., New Kensington, Pa. (protect per request), advised SA THOMAS G. FORSYTH, III:

The MANNARINOs have purchased some new property near Camp Jo-An, Pa., in Westmoreland County. A New Kensington, Pa., real estate agent, A. F. BOYER, handled the transaction.

On 5/3/61, PC 615-C advised SA FORSYTH:

As yet, KELLY MANNARINO has not installed a telephone at his cottage near Leechburg, Pa. When he wishes to make a telephone call, he goes down Old Leechburg Road about a quarter of a mile to a Meadow Gold Dairy farm and uses a coin telephone. It is believed, however, that when MANNARINO commences permanent summer residence at the cottage, which is imminent, he will want a telephone installed on the premises.

Pittsburgh will remain in contact with the local telephone company official who can advise when a telephone application is made by MANNARINO.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
