On 5/20/51 FU 015-C advised SA THOMAS G. FORSYTH, III as follows:

At 9:00 PM on 5/22/61, SAMUEL MANNARINO, who controls all gambling and rackets in the New Kensington, Pa., area, departed from New Kensington with VICTOR STANZIANO in the latter's car. They drove to New York City, reason unknown. While there, they visited an Italian restaurant known as the 71st Street Cafe but located on 69th Street. The proprietors of this restaurant are friends of SAMUEL MANNARINO. Both men returned to New Kensington the evening of 5/23/61.

STANZIANO is a New Kensington swimming pool and building contractor. His wife is believed to be a cousin of the MANNARINOS. STANZIANO is currently associated with SAMUEL and GABRIEL MANNARINO in a project to develop into residential and commercial property 400 acres of land owned by the MANNARINOS in Allegheny Township, Westmoreland County, Pa.
