Activity at the various gambling establishments in New Kensington, Pa., continues unusually slow as it has since the defeat of Mayor RAYMOND GARDLOCK in the primary elections of 5/16/31. Many of GABRIEL MANNARINO's "small fry" employees are complaining because in general their incomes are based on commissions from the volume of gambling receipts. Even the "after hours" drinking establishments are doing very little business.

GABRIEL MANNARINO's eldest daughter, GEORGIENNE, is to graduate from New Kensington High School on 6/7/61. It is expected that she will receive many handsome gifts, including an automobile from her father.
