Re Miami letter with enclosures, 7-23-69.

On 9-8-69, former MM 639-S contacted the Miami Office and advised he recently had received a letter from captioned individual. DEMPSEY said he was still residing in Canada and is in association with an American in Ottawa, Canada. This American, not further identified, is writing a book about the assassination of JOHN F. KENNEDY and has been in contact with GERALD PATRICK HEMMING, LORENZO HALL and LARRY HOWARD.

CALIF

Source explained that HEMMING, HALL and HOWARD are American adventurers and mercenaries and were active in Cuban revolutionary matters in Miami in 1962. They are presently residing in the metropolitan area of Los Angeles, California.

Source said he expected to be contacted again in the immediate future by the subject inasmuch as Haitian exile leader, Colonel RENE JUARES LEON, is now out of jail and is interested in continuing in Haitian revolutionary activities.
