Careful consideration has been given to the use of T symbols in this report and they have been used only in those instances where it is necessary to conceal the source.

Detroit Informants DE 370-C, DE 878-C-TE, DE 889-C-TE, and DE 906-C* have furnished considerable information in the past which cumulatively reflects good over-all coverage of the Detroit "Family", but every effort is being made to develop new sources which can authoritatively define the organization in the light of current organizational changes. It is to be noted that the local organization appears to be undergoing a change, with JOSEPH ZERILLI, reported "Commission" member and the "elder statesman" becoming more inactive while the second generation leadership is apparently beginning to take over. It has not been authoritatively determined whether the organization of the Detroit "Syndicate", including non-Italians, coincides in all respects with the organization of "Causa Nostra".
