Re Milwaukee letter to Chicago, 10/16/64, captioned as above, and Milwaukee airtel to Bureau, 11/19/64, captioned "MI 623-C-TE, TECIP".

Prior to interview of MI 623-C-TE on 11/25/64 by SAs RICHARD C. THOMPSON and ALEXANDER P. LE GRAND, recent reports on FRANK BUSCEMI and JOSEPH ZAMMUTO furnished by Chicago were reviewed and names were selected therefrom for the purpose of stimulating informant's recollections regarding the La Cosa Nostra family in Rockford.

JOSEPH "GRAMPS" MARINELLI

Informant said MARINELLI was a member of the La Cosa Nostra family, Rockford, Illinois, and was made while TONY MUSSO was boss--perhaps ten years ago. He is a man in his 50s, and he runs around the country a lot and has been a siding salesman.

NUNZIO INGRASSIA

Informant said he is not a member of La Cosa Nostra but is close to members. He now operates a furniture store but
