On 12/2/64 MI 623-C-TE advised as follows:

CARL ROSPI, 232 Hollywood, Cuyahoga Falls, Ohio, died recently and was buried early this week. Funeral arrangements handled by Rossi Funeral Home. Informant learned of this in Rockford, Ill. where ROSPI was acquainted because he once hid out there when wanted for murder years ago in Ohio. No one from Rockford went to the funeral but Cleveland was probably well represented as ROSPI was a La Cosa Nostra member of long standing.

The only La Cosa Nostra family activity in Rockford about which informant learned on recent trip there consisted of a dice game run by CHARLIE VINCE and the usual jukebox and coin machine operation of FRANK BUSCEMI. The dice game is somewhere on South Main Street and is referred to by a name such as Sportsman's Club or South Side Businessman's Club.

PHIL CANELLA of Rockford LCN family is disappointed and dissatisfied with family affairs. Informant suggested contact with CANELLA but said contact should be very circumspect so that CI will not be compromised. No statement should be made to CANELLA indicating positive knowledge that he belongs to LCN.

PHIL PRIOLA of Rockford is going into hospital for operation on ulcers.
