Re Miami letter to Bureau dated 10/28/64.

On 11/17/64, Supervisor JOSEPH AHEARN, INS, Newark, New Jersey, made available subject's Alien file number A 12809191, disclosing the following:

HECTOR ALFONSO RUIZ, born 5/12/39, Havana, Cuba, arrived in the United States on 8/8/64, with an I.O. Visa issued by United States Embassy, Madrid, Spain. He was sponsored by, "REINALDO PICO and JORGE JULIO ROJAS, Box 1444, Miami, Florida," and was destined to reside with a friend, "MANUEL RODRIGUEZ DIAZ, 341 S. West 5th Street, Miami." Fla. As of 10/10/64, he listed his address as 110 Albert Avenue, Newark, New Jersey.

Background given by RUIZ indicated that he had favored FIDEL CASTRO prior to 1959, having had a previous association with the legal Autentico Party in Cuba. Following the revolution he was arrested and incarcerated by the Castro Government on three occasions during 1961 and 1962. From 1960 to 1964, he indicated that he belonged to the anti-Castro group of LUIS CONTE AGUERO known as Movimiento de Recuperacion Revolucionaria (MRR). He sought asylum and spent ten months in the Uruguayan Embassy in Havana, Cuba, and later lived in Spain prior to his arrival in the United States.

As RUIZ was found to have moved from 110 Albert Avenue, Newark, and his address was unknown he was not able to be contacted until 12/3/64, after his calling the Newark Office. He now resides at 112 Jefferson Street, Newark, New Jersey, and is employed by Deluxe Ready Plastics Company, Elizabeth, New Jersey.
