It has been previously reported that CONRADO RODRIGUEZ SANCHEZ, a Cuban exile and former labor leader in Cuba, now residing in Miami, represents the Accion Sindical Independiente (ASI) and the Junta Cubana Revolucionaria (JCR). The ASI is the labor group of JCR.

In December, 1972, and January, 1973, information was received indicating that RODRIGUEZ planned to begin terrorist activities in the event the United States should sign an agreement with FIDEL CASTRO of Cuba. RODRIGUEZ reportedly said that the principal targets would be ships and diplomatic offices belonging to countries which trafficked with Cuba.

On February 26, 1973, as previously reported, a Miami source who is acquainted with some members of the ASI, reported that RODRIGUEZ intended to kill five individuals, since the United States had entered into an agreement with Cuba on the subject of hijacking. He named one of his intended victims as a professor who has been identified as Professor JAIME SUCHLICKI, a Cuban national of Polish origin, who is

on the staff of the University of Miami. When interviewed on March 1, 1973, by Special Agents of the FBI, RODRIGUEZ denied that his organizations had any intention of violating any U. S. laws by attacking ships, diplomatic establishments, or any individuals in the U. S. or elsewhere.

CURRENT DEVELOPMENTS

On April 9, 1973, the same Miami source reported that RODRIGUEZ reiterated that sometime within the very near future, his men would place bombs in the homes of some individuals who are working for peaceful co-existence. He said that after these attacks, credit for same would be claimed by a fictitious clandestine organization. He added that his plans included attack on some ship which is trafficking with the CASTRO regime. He did not identify any of the individuals whose homes he said he would bomb, nor did he identify any particular ship or the country of registry of any such ship.

Source informed RODRIGUEZ that he had learned through friends at the University of Miami that SUCHLICKI is opposed to peaceful co-existence between the United States and Cuba, that SUCHLICKI has the reputation of being anti-Communist, and that SUCHLICKI appeared on a Miami television program where he definitely expressed himself in opposition to peaceful co-existence. RODRIGUEZ said that might be so, and that in any event, he is too busy with other plans to be concerned about SUCHLICKI.

Source reported on April 12, 1973 that RODRIGUEZ disclosed on the previous day that he will continue his plans for bombings, but again he did not supply the targets. The source said that RODRIGUEZ is now employed as a salesman at Biltmore Motors, Miami.

It is to be noted that in the past, RODRIGUEZ has disclosed the existence of plans of violence to other sources, but none of these have yet been carried out.

For information of the Bureau and Miami, pertinent sources of the Los Angeles office have no information that branches or representatives of the captioned organizations exist in the Los Angeles area.

It is noticed that the only information suggesting there are representatives in the Los Angeles area originate with CONRADO RODRIGUEZ SANCHEZ himself, whose motives have been previously questioned (see New York letter 1/31/72). When previous inquiry was conducted in the above matters, ARTURO RODRIGUEZ VIVES of New York City, then Minister of Exterior Affairs for the JCR, advised he was unaware of any representative or contact in Los Angeles (see New York letter 12/10/71).

Pertinent sources, notably CSLA 3184-S, CSLA 4703-S, LA 6549-E (URBAN) and representatives of the Criminal Conspiracy Section of the Los Angeles PD (which has investigated anti-Castro terrorist-type activities in the past) have been alerted to the possibility of the revival of such activities in view of the recent United States - Cuba skyjacking agreement and to the necessity of immediately reporting such incidents to this office.

For the information of the Bureau, in order to protect MM 1337-S, prior to interviewing RODRIGUEZ, Special Agents WILLIS E. WALTON and GEORGE E. DAVIS, JR. interviewed ANDRES NAZARIO SARGEN, head of Alpha 66, and JUAN JOSE PERUYERO, head of Brigade 2506, and notified them that they were being served with a warning that the U.S. Government would vigorously investigate and prosecute any violations of Federal law occasioned by Cuban exiles in opposition to the hijacking agreement between the United States and Cuba. Both of these individuals were requested to pass the word along to other Cuban exile organizations and individuals. This was done in order to protect MM 1337-S by giving RODRIGUEZ the impression that his interview by FBI Agents was the result of a general program.

Also, as an additional means of causing RODRIGUEZ to cancel out his plans against SUCHLICKI, MM 1337-S was instructed to notify RODRIGUEZ that he had researched SUCHLICKI by making inquiry of some of his contacts at the University of Miami and had determined it would be a grave mistake for RODRIGUEZ to attack SUCHLICKI in any way since SUCHLICKI is an ardent anti-Communist and anti-CASTRO.

In December, 1972, and January, 1973, information was received, as previously reported, that CONRADO RODRIGUEZ SANCHEZ disclosed that his Cuban labor organizations had made arrangements to begin terrorist activities in the event the United States should sign an agreement with FIDEL CASTRO of Cuba. RODRIGUEZ stated that the principal targets would be ships belonging to countries which traffic with Cuba and that other targets would be Diplomatic Offices of countries which maintain relations with CASTRO. He also included terrorist attacks against individuals, Cuban or foreign, in the United States who collaborate with or sponsor co-existence with the CASTRO Regime.

It has been previously reported that RODRIGUEZ, a Cuban exile and former labor leader in Cuba now residing in Miami, represents the Accion Sindical Independiente (ASI) and the Junta Cubana Revolucionaria (JCR). The ASI in the labor group of the JCR.

subject of hijackings. RODRIGUEZ named one of these intended victims as a Professor JAIME SOSLICKI (phonetic) of the University of Miami and formerly of Cuba. RODRIGUEZ described SOSLICKI as a Polish professor and member of the "Radical Left" who had made trips to Chile.

RODRIGUEZ expressed the desire for publicity and said that he would use a phone name "Comandos Pedro Luis Boitel" in order to claim credit for these acts of terror.

RODRIGUEZ commented that he is now in the process of collecting information concerning the habits and routine of SOSLICKI. RODRIGUEZ did not furnish further details.

On February 26, 1973, Mr. DAVID WIKE, Associate Director of Security, University of Miami, advised that a Professor JAIME SUCHLICKI, a Cuban National of Polish ancestry, is on the staff at the University of Miami and has been making international studies on the subject of Latin American revolutions and counter-revolutions. He has also authored books concerning revolutionary activities of students. One of his recent books is entitled "Cuba, Castro and Revolution". Mr. WIKE described Professor SUCHLICKI as being a research analyst and anti-Communist. He was also one of the motivators of the American Institute of Free Labor Development which concluded several days ago a 2-week session at Miami Beach.

Pertinent information concerning the alleged threat made against Professor SUCHLICKI, as described above, was furnished to Mr. WIKE who said he would immediately notify Professor SUCHLICKI, the Coral Gables, Florida Police Department which has jurisdiction over the University of Miami, and the Dade County Public Safety Department which has jurisdiction over Professor SUCHLICKI's residence at 8800 S.W. 54th Terrace. Mr. WIKE also agreed to immediately provide security for Professor SUCHLICKI on the University of Miami Campus.

On February 27, 1973, MM T-1 advised that he had been unable to obtain any additional information from RODRIGUEZ who has indicated that at the present time he is laying the ground work for carrying out his plans.

On March 1, 1973, Special Agents of the Federal Bureau of Investigation interviewed CONRADO RODRIGUEZ SANCHEZ at a construction project in the 800 block of Ponce De Leon Blvd., Coral Gables, Florida, where he was working.

RODRIGUEZ was notified that any violations of Federal law or State law by Cuban exile organizations or anyone else based upon opposition to the recent hijacking agreement between the United States and Cuba would be vigorously prosecuted.

RODRIGUEZ asserted that his organizations, the ASI and JCR, have no intention whatsoever of violating any U.S. laws by attacking ships, diplomatic establishments or any individuals in the United States or elsewhere, despite the fact that he is personally opposed to the hijacking agreement. He explained that his opposition is based upon that portion of the agreement which requires the U.S. to return to Cuba political refugees who flee that country.

RODRIGUEZ said that he has learned from the example concerning the prosecution by the Federal Government of ORLANDO BOSCH AVILA, a notorious bomber convicted in 1968, that it is foolish to engage in such acts of violence.

RODRIGUEZ added, however, that he will, through freedom of speech, continue to oppose the Communist Regime of FIDEL CASTRO and will voice opposition to peaceful co-existence with Cuba. RODRIGUEZ said that he is personally depressed by the fact that the new generation of Cuban exiles in this country have little knowledge or interest in the Cuban problem as it exists today.

Rodriguez stated that they have their best men for such activities in New York, New Jersey, Los Angeles, San Francisco, Washington, D. C., and Miami. Rodriguez also claimed that terrorist attacks would be carried out against individuals, Cuban or foreign, in the U.S. who collaborate with or sponsor coexistence with the Castro regime. Although Rodriguez gave no specific dates as to when such activities would allegedly take place, he indicated that they would be put in effect at some time in the future.

It is absolutely essential that Miami closely follow this matter, particularly since the U. S. and Cuba have recently reached an agreement on hijacking.

Recipient offices be certain that all logical sources and informants are targeted to immediately report any data which may have bearing on this matter.

In view of the seriousness of the allegations, Miami promptly interview Rodriguez. Be certain interview is handled in such a way that MM 1337-S is not jeopardized. If not already done, Miami be certain that appropriate local police authorities are aware of Rodriguez' plans.

Keep Bureau currently advised of all pertinent developments in form suitable for dissemination.

Agents handling this matter should be aware of the provisions of the recent legislation entitled "Act for the Protection of Foreign Officials and Official Guests of the U.S." In the event a crime is committed which is covered by the Act, the Bureau should be immediately advised in sufficient detail so that a meaningful discussion can be held with the Department of Justice and a determination made regarding further action.

Previous investigation has reflected that CONRADO RODRIGUEZ SANCHEZ, a Cuban exile and former labor leader in Cuba, now residing in Miami, represents the Accion Sindical Independiente (ASI) (Independent Labor Action) and the Junta Cubana Revolucionaria (JCR) (Cuban Revolutionary Board). The ASI is the labor group of the JCR. The ASI is headquartered in Miami, and the JCR in New York City. In March, 1972, it was reported that RODRIGUEZ disclosed that he was making contact with various labor organizations in Latin America to develop a plan to attack communist and pro-communists in Latin America.

On November 22, 1972, MM T-1 who is acquainted with some members of the ASI in the Miami area advised that RODRIGUEZ disclosed that on November 24 and 25, 1972, there would be a national conference in New York City of members of the ASI and the JCR along with some young Cubans who had received military training. RODRIGUEZ said that although it would be specifically announced that this was a political meeting, the real purpose of the convention was to work out plans on a national level for terrorism in the event United States and the communist Cuba should reach some kind of an understanding or political arrangement. He claimed that if such an agreement was entered into between the United States and Cuba his group would be ready to carry out sabotage all over the United States and Canada. He asserted that he already has explosive experts located in various parts of the United States.

On December 8, 1972, MM T-1 advised that RODRIGUEZ after returning from the congress in New York City, said that those in attendance had taken the necessary measures and reached the necessary agreements so that if the United States signed an agreement with FIDEL CASTRO, they could begin terrorist activities in the United States. He said that the principal targets would be ships belonging to countries which traffic with Cuba. Other targets would be the diplomatic offices of countries which maintain relations with CASTRO. RODRIGUEZ emphasized that they would avoid attacks against American ships or installations in order to avoid prosecution by United States investigative agencies. RODRIGUEZ said that the places where they have their best men for such activities are New York, New Jersey, Los Angeles, San Francisco, Washington, D.C. and Miami.

On January 31, 1973, MM T-1 advised that RODRIGUEZ had just disclosed that his organization has now established all the necessary connections with various labor organizations in Latin America and the United States to carry out sabotage against property of the Castro regime along with the property of any country which maintains relations of any type with CASTRO.

RODRIGUEZ pointed out that he has confidential relations with the AFL-CIO which is willing to make economic contributions and supply confidential information on the ports where ships tie up with merchandise from the communist world.

RODRIGUEZ pointed out that at the moment, more than six major organizations in six different countries have promised to work together to carry on sabotage activities against the communist regime in Havana. He also claimed that they would carry out terrorist attacks against individuals, Cuban or foreign, in the United States who collaborate with or sponsor co-existence with the Castro regime. He said that they already have explosives located in various countries

including the United States, where their organization is the strongest.

MM T-1 said that RODRIGUEZ indicated that these plans would be put into effect at sometime in the future but he did not indicate any specific dates. MM T-1 said that RODRIGUEZ has, on previous occasions, talked about engaging in organized acts of violence, but has not done so to date.

MM T-1 described RODRIGUEZ as being a shrewd individual who has the reputation of having been involved in acts of violence while a labor leader in Cuba.
