The Newark Office by letter dated June 17, 1958 identified LOUIS KROMBERG as a contact of CELLINI in the Newark area. KROMBERG was identified as a prohibition era gangster who now controls the Liquor Salesman Union in New Jersey. KROMBERG is further identified as an associate of GERARDO CATENA, notorious La Cosa Nostra figure. Miami requested KROMBERG be interviewed. Newark advised that KROMBERG since May, 1968 has been under development under the TECIP of the Newark Office. It was felt that an attempt to interview KROMBERG regarding CELLINI at this time would be premature. It has been recommended that the interview of KROMBERG be held in advance until such time as it is believed that he will fully cooperate.

Information copy of this report has been furnished to the Newark and New York Offices each, in view of the continuing interest of these offices in DINO VINCENT CELLINI.
