Information obtained from the Legat at Bonn in December, 1968, has revealed that CELLINI was in Aruba April 20, 1968, and at this time, made an offer to supply slot machines to the Aruba Sheraton Hotel

It should be determined whether or not CELLINI is a regular customer of the Bally Company. A record of his contact with the company should be obtained. Based upon the information received from Chicago, it will then be determined whether or not CELLINI has a license to legally engage in this business.

MM T-2 advised on January 23, 1969, that
DINO CELLINI continues to use the services of Alitalia
Airlines. This source advised that DINO CELLINI arranges
the flight reservations, for his customers, through the
Dupont Plaza Travel Service, which is located in the
Dupont Plaza Building, Miami. The source advised that
junket flights are arranged for travel to London, England,
to the Colony Sporting Club. Passengers board Alitalia
Airlines at New York.

MM T-3 advised on December 12, 1967, that DINO VINCENT CELLINI traveled to Aruba on December 1, 1967, and again on April 20, 1968. Source advised that on the occasion of his trip in April, 1968, he was in contact with the Aruba Sheraton Hotel and made a bid to supply the casino with slot machines. Source also advised that during the period April 21 - 24, 1968, CELLINI also visited Curação and San Juan, Puerto Rico

MM T-7 advised that DINO CELLINI on September 26, 1967, opened a business account at the First National Bank of Miami under the name of Travel and Resort Enterprises, Inc. The source advised that as of August 1, 1968, the balance of this account was \$2,737.01. The account was closed by CELLINI on September 10, 1968.

During the period January 17 - January 21, 1969, MM T-4 was Contacted concerning his knowledge of the SANTO TRAFFICANTE, JR., operation in the Miami area. This source advised that DINO CELLINI is a close friend of SANTO TRAFFICANTE, JR., and may be tied in with TRAFFICANTE in his gambling operations. Source advised that CELLINI is known to be a contact of GARCIA VIDAL, who is closely tied in with TRAFFICANTE in gambling matters. Source also advised that CELLINI is associated with SAMMIE MONDELLO, an associate of TRAFFICANTE from Tampa, Florida.

Source has advised that SANTO TRAFFICANTE, JR., is interested in gambling asino ventures throughout the Caribbean area.
