ReBulet 12/28/64, granting authority for Philadelphia to retrieve equipment previously used in misur coverage, 775 S. 8th Street, and authority to / reestablish misur coverage at this location.

On 1/13/65 SA ALBERT L. PIERCE, under pretext of telephone repairman, retrieved the altered 44A block at 775 S. 8th Street. SA PIERCE also, through wiring presently in the building, traced an inside 10 or 11 pair cable, which appears in the rear room, 775 S. 8th Street. The red-blue pair of this cable was connected to the outside box and presently runs to the CP, Philadelphia.

Philadelphia will continue to maintain the altered 44A block retrieved 1/13/65 on their inventory. The missing 44A block described in Philadelphia letter of 12/17/64 is being deleted from Philadelphia inventory.

Enclosed herewith is a portion of the cover for the above-described 10 or 11 pair inside cable. It is requested that Philadelphia be forwarded a Minimite. This minimite will be installed inside the cable and accordingly, a minimite of the smallest proportions is needed for this purpose.
