NEWARK

AT BAYONNE, NEW JERSEY (1) Will examine INS records to determine if TORTORA under his true name or any of his aliases, filed a declaration of intention to become a U. S. citizen in about 1932. Will furnish available background information from the declaration.

- 2. Will check records of Bayonne Police Department for any record of arrest for TORTORA under his true name or aliases.
- 3. Will check same records for any arrest record for JOHN ROSELLI, aka., Felipe Sacco, Phillipe Sacco or Philip Sacco, James F. Stewart.
- 4. Will determine what information the Bayonne Police Department and logical informants might have concerning TORTORA's "Union Siciliano" activities during this period (1926-1934).
- 5. Will endeavor to verify his operation of a grocery store at 122 West 23rd Street, Bayonne, New Jersey from 1929 until May, 1934.
- 6. Endeavor to ascertain if GUISEPPE GALLO, who in 1934 was residing at 168 West 21st Street, Bayonne, New Jersey, is still alive. GALLO came from vicinity of Naples, Italy, and being a close friend of TORTORA, may also have known ROSELLI (SACCO) and his family.

The Bureau has advised that information furnished by LA 4448-C-TE that the true name of JOHN ROSELLI, aka., is FELIPE SACCO is not to be disseminated outside the Bureau and is to be given maximum security handling. In covering the leads set out above, it should not be divulged that the inquiries concerning TORTORA and SACCO have any connection with the investigation of ROSELLI.
