On 4/16/65, GEORGE HOPKINS advised that a good looking woman about 26 years old, 5'6" or 7" tall, slim build, and long bleached blond hair has been staying with ROSSELLI for the past several days and on 4/15/65 she and ROSSELLI moved a lot of her clothes into ROSSELLI's apartment. HOPKINS will endeavor to obtain the name of this woman.

On 4/13/65, LA 4145-C advised that he had learned from FRANZ BREITLING, owner of Ajax West Coast Corporation, Santa Barbara, California, that ROSSELLI recently sold about 26 Kold Draft ice cube machines to some establishment in Las Vegas, Nevada, and has potential orders for about 100 additional machines within the next several months. ROSSELLI sells ice cube machines and Ajax West Coast Corp. sends the machines to the buyer, collects the money, and then sends ROSSELLI a check for this profit on the sale. In this connection, recent examination of ROSSELLI's bank account at the Fidelity Bank, Beverly Hills, California, revealed a deposit of a check for \$525.72 drawn on the Crocker-Anglo National Bank, Santa Barbara, California. In the past ROSSELLI has received check from the Ajax West Coast Corp. which were drawn on this bank and this check was probably a payment for ROSSELLI's profit on the sale of ice cube machines.
