Immediate interview of these persons is not being requested because it is not considered desirable at this time to conduct any interviews in this case in Chicago, Boston or other places in the United States which might jeopardize the security and/or safety of LA 4448-C-TE or the security of this investigation by the premature disclosure of the fact that the Bureau is aware of ROSSELLI's true name, PHILLIP SACCO. Plans are presently pending to interview TANCREDI and PARIGIT TORTORA in Italy. Both of these men are reportedly aware of ROSSELLI's dual identity. Subsequent to these interviews, whether or not the TORTORAS are cooperative, more open investigation will no doubt be desirable and it may be possible through appropriate inferences to prevent the conclusion being drawn by the person interviewed, that the original source of information concerning ROSSELLI's true name was LA 4448-C-TE or was from the California area. Every precaution should be taken to protect LA 4448-C-TE as the informant.

The TORTORA interviews are key interviews and should the TORTORAS be cooperative, they will be able to furnish information of great value to this investigation.

Subsequent to the interviews of the TORTORAS, it is suggested that consideration be given to the convening of a Federal Grand Jury in Boston or Los Angeles or both places, to which ROSSELLI's immediate relatives, former associates and friends who are known to be aware or who can reasonably be assumed to be aware of his dual identity could be called. Potential witnesses in this group would include some high ranking and other members of La Cosa Nostra throughout the United States. It does not appear that such witnesses would have a legitimate reason to refuse to testify on the basis of self-incrimination and such testimony on the part of La Cosa Nostra members would no doubt be a source of considerable embarassment to them as members as well as to the organization.
