the Tournament of Champions (Golf Tournament) is being held at the Desert Inn Country Club from 4/29 through 5/4/65 and this may account for ROSELLI's trip to Las Vegas at this time.

On 4/29/65 GEORGE HOPKINS, supra, advised that the apartment was holding mail for ROSELLI and two pieces of mail bore the return addresses, respectively, of "D:O. Box 472, Place d'Armes, Montreal, Canada," and "Jubilee Iron Corporation, 630 Dorchester Blvd., W., Montreal, Canada."

Mr. HOPKINS further advised that ROSELLI is frequently called by Mr. and/or Mrs. CROSBY. It is recalled a couple of weeks ago ROSELLI was observed having dinner with LINDSEY CROSBY and two women.

On 4/27/65 CHARLES BUONORA, 1442 Westwood Boulevard, West Los Angeles, who operates Buonora Art School at this address, advised that KATHLEEN ROSSELI, 1333 South Beverly Glen Boulevard, West Los Angeles, telephone 474-4526, was a student at his school in November, 1964. She paid \$10 for one month and attended classes about twice during November. BUONORA said that KATHLEEN did not refer to herself as Mrs. ROSSELI or furnish any information about ROSELLI, except to state that they travel a lot to Las Vegas, San Francisco (and elsewhere) and she would probably have to miss some classes. BUONORA advised that he knows of JOHN ROSSELLI through reading the book "Green Felt Jungle" and he assumed that KATHLEEN's husband or boy friend was JOHN ROSSELLI. KATHLEEN listed her hobbies as golfing and water skiing and started classes to learn to paint and draw. BUONORA said she was an intelligent, attractive girl. After she quit attending classes, he called her residence once or twice and could not reach her and has not seen her since some time in November, 1964.

LV 10-C furnished information on 4/26/65 that RUBY KOLOD made reservations for a Mr. and Mrs. FLETCHER JONES at the Desert Inn Hotel at the request of JOHN ROSELLI. JONES indicated that he would stay for seven nights. Mr. and Mrs. JONES are listed as "top priority" by the hotel and it was indicated they were in Las Vegas for the Tournament of Champions. It is probable that JONES is the automobile dealer from Los Angeles. Information was recently received by the Los Angeles Office that FLETCHER JONES, the automobile dealer, is an ardent golf fan.
