Supervisor Morgan of the Washington Field Office called this morning to advise that, according to WF 1134-S*, Lieutenant Joaquin Bertran, Assistant Cuban Military Attache, called Doris Saavedra, wife of the Cuban Military Attache, and told her not to attend the subcommittee meeting on the Hill today, where Pedro Diaz Lenz is to testify; that it would be too dangerous. Pedro Diaz Lenz is the former head of the Cuban Air Force, who defected, and who is scheduled to testify before the Senate Internal Security Subcommittee.
