FOREIGN POLITICAL MATTERS-CUBA

On December 8, 1959, a confidential informant, who has furnished reliable information in the past, learned that the Cuban Consulate in Miami, Florida, had requested that the Cuban Foreign Ministry send the necessary documents to effect the extradition of Pedro Diaz Lanz from the United States to Cuba. These documents were to arrive in Miami prior to January 2, 1960. *[Handwritten initials]*
