Sources familiar with Cuban activities in Puerto Rico have been alerted to furnish any information concerning the activities of the captioned organization. They are: SJ 492-S, SJ 533-S, CSSJ 486-S, and PSI.

DELEGATE OF SUSPECT ORGANIZATION

On 4/19/65, EUGENIO LAFITTE TABOADA, Cuban exile and insurance broker with offices at 302 Calle Comercio, San Juan, P. R., advised that he is currently the Puerto Rico delegate of captioned group. He stated that captioned group has no equipment in Puerto Rico, conducts no training of any sort and does no recruiting. They are in Puerto Rico only for propaganda activities and for fund-raising. The organization numbers less than 30 men in Puerto Rico at this time. He stated that the MIRR has never had any boats or airplanes in Puerto Rico. He stated that he did not know the name of MODESTO GUERRERO or of a minister named ISIDRO RAMON.

SJO will maintain contact with established Cuban sources in Puerto Rico and follow activities of the MIRR.
