A member of a group of Cuban émigrés trained in the techniques SOURCE: of information collection. The group has provided useful reports This information was obtained from Manuel Cobo Sausa. since 1961.

- On 5 April 1965, Manuel Cobo Sausa, a leader of the Movimiento Social Democrata (MSD, Social Democratic Movement), who had just returned from Venezuela, maintained that isolated actions against points in Cuba would not succeed in overthrowing Fidel Castro Ruz. He thinks it is better to carry out continuous actions on key objectives, such as electric plants and petroleum plants, not against sugar mills. He said his organization has planned five such actions, for which he needs about \$65,000, half of which he has succeeded in raising.
- In December 1964, Cobo lost a considerable part of his armaments just a few minutes before boarding a small plane to fly to Cuba; 1 he was surprised at the airport in Pompano Beach by Customs officials. He believes that he was denounced by his co-pilot Evelio Alpizar Perez. Cobo said that Alpizar has on previous occasions, denounced the Movimiento Insurrectional de Recuperacion Revolucionaria MIRR, insurrectional Movement for Revolutionary Recovery), which is headed by Dr. Orlando Bosch Avila? Cobo has obtained new arms and ammunition to replace those he lost. He may have to rent a plane for his group. Cobo added that the trips by boat to Cuba have been very dangerous and expensive.

## Field Comments

- The incident occurred on 2 December 1964.
- Alpizar has boasted of flying missions to Cuba for the MIRR. Source commented that Alpizar said that a pilot who is now flying in the Congo denounced Cobo.
