Enviries through Bertie Township Police Department, Ridgeway, Untario revealed that Mildred ALOLEY, who resides on Victoria Avenue, R.B. #2, Hidgeway, is the wife of Walter J. MAHONEY, Attorney, wrine Trust Building, Buffalo, New York. It was also learned that Walter J. AHONEY is a brother of William and WEY, State Senate Majority Leader of the State of New York.

2. Sgt. R. SHULTZ, Bertie Township Police, who is a close friend of the MAHUMEYS, advised that Charlotte .WYER is a divorcee from Philadelphia who visited mildred MAHONEY at Ridgeway during July 1902, having met the APONEYS at a race track in Florida. According to SouLTZ, mildred MAHONEY will be leaving for Florida within the next week and will not be retarning to Canada until the summer of 1903.
