on how to fill out his "application". The informant was of the opinion that this application was an application for registration with the Waterfront Commission of New York Harbor. Both GLEASON and NOONAN advised ENGLISH not to put down that he was arrested or indicted and that he should take his chances that he can get by the Waterfront Commission's "screening". They pointed out that if ENGLISH got caught, "that was that".

NOONAN explained to GLEASON that he intends to call Yale Transportation Company and M & M Transportation Company to try to get a job for ENGLISH. NOONAN stated "I will call Gene (ph) and then Pat Everett (ph)". NOONAN made a telephone call and asked for GENE SULLIVAN (ph). Apparently when he was advised that SULLIVAN was not in, he asked for RED BARNEY. It is noted that RED BARNEY is employed by Yale Transportation Company, and it is further noted that in March, 1963, NY 1716-C advised that a (FNU) SULLIVAN, the son of FARMER SULLIVAN an ex-convict, is a shop steward at Yale Transportation and is one of JIMMY ALO's men.

NOONAN was unable to get either SULLIVAN or BARNEY and then called PAT EVERETT and arranged to send ENGLISH over on April 10 to get a job with M & M Trucking Company.

From a review of the indices of the NYO, it was determined that MATTHEW ROBERT ENGLISH is one of the subjects of NY File 15-26106. Discussion with the case agent of this file indicates that ENGLISH is due to appear in USDC, EDNY on May 20, and that FRANKIE DOTO is involved in some manner in this case. A recontact will be made with NY 3778-C* by the agent handling this informant and the case agent handling NY File 15-26106. Any additional information obtained through this recontact will be furnished to the Bureau.
