Bureau's attention is directed to case entitled "UNSUB; Connie Noonan; LMRA 1947 (IM)", NY file 122-719, no Bufile number shown.

The investigation in this case was instituted to determine if NOONAN had received kick-backs or other favors from truck firms in the NYC area for his having changed from checking systems at truck barns where members of Local 1730 were employed.

By report of SA BOYD B. HENRY, JR., dated 1/18/60, at NY, the Bureau was advised that the USA, SDNY, indicated that there was not sufficient indication of a violation to warrant investigation.
