Upon the completion of the telephone call, two unknown individuals entered NOONAN's office. The informant advised one was BERNIE (LNU) and the other one, whose name the informant could not furnish, was described by the informant as an individual living in Yonkers, NY, who is suffering from high blood pressure which consequently forced him to seek employment requiring little exertion and who worked with MICKEY MC LOUGHLIN (ph) some 12 or 13 years ago on Pier 58. The two unknown subjects requested NOONAN's assistance in obtaining a job for the unknown subject with high blood pressure. NOONAN first remarked that Local 807 (IBT) is no good and, therefore, he will try Local 707 (IBT). NOONAN called NICK (LNU) at Local 707, IBT, and requested NICK's assistance in obtaining a position for the unknown individual. Upon completion of the call, NOONAN advised that NICK is going to call back and that meanwhile the two unknown individuals should remain in NOONAN's office.

BERNIE (LNU) asked NOONAN "how's the big fellow, EDDIE." NOONAN's answer is inaudible. It is noted that NY 1716-C has advised in the past that the term "big fellow" is used among NOONAN's associates when referring to EDDIE MC GRATH. BERNIE (LNU) then remarked "MURPHY is in Candlewood (?)" and "what do you think of SONNY CAMPBELL?" There follows a general discussion and conversation between the two unknown subjects and NOONAN regarding CAMPBELL's arrest and the fact that CAMPBELL is out on bail. The unknown individual from Yonkers remarked that he saw CAMPBELL's sister, GRACIE, the day before yesterday (5/5/63) and NOONAN remarked he never thought that "they" would let him out on bail. NOONAN discussed CAMPBELL's forthcoming trial and stated the best that CAMPBELL could hope for is a hung jury. NOONAN remarked that there are a number of individuals involved in this matter and some are doing five years, some are doing seven and a half years, and some are doing 15 years and "you can bet your life that none of those doing 15 years are snitching." NOONAN is of the opinion that CAMPBELL is in serious trouble and again reiterated that the best CAMPBELL can hope for is a disagreement among the jurors.
