9. Informant furnished the following information on dates indicated:

On 5/6/63, information concerning FRANK SCIREMAMMANO, subject of NY 15-25416. Informant advised that SCIREMAMMANO discussed with CONNIE NOONAN and AUSTIN FUREY the fact he had been arrested by the FBI, that he had denied previous arrests to the "Feds", whereas he had a previous record, and that he believed the "stool pigeon" who "framed" him did not know him personally.

On 5/7/63, information re JOHN JAMES NORTON, subject of NK 15 case, FBI #62676E, and re EDDIE MC GRATH, NY 92-667, and FRANK "SONNY" CAMPBELL, NY 9-2247. Re NORTON, informant advised that NOONAN described NORTON to TEDDY GLEASON as "Nunzy's friend" and that NORTON tried to "bolt into (local) 560" (IBT). NOONAN indicated he would not bother with NORTON except that NOONAN has been put under some sort of pressure.

Re MC GRATH and CAMPBELL, informant advised that BERNIE (LNU) asked NOONAN, "how's the big fellow, EDDIE?" NOONAN's answer was inaudible. NY 1716-C has advised in the past that the term "big fellow" is used among NOONAN's associates when referring to EDDIE MC GRATH. BERNIE (LNU) and NOONAN then discussed SONNY CAMPBELL's arrest by the FBI. NOONAN remarked that the best CAMPBELL could hope for would be a hung jury.

On 5/15/63, information re TEDDY GLEASON discussing the fact that TONY PROVENZANO and JIMMY HOFFA attempted to intercede in a pending local 1730 ILA strike because it would "louse up" the Teamsters.

On 5/22/63, information re comments of CONNIE NOONAN and AUSTIN FUREY re the arrest of BUSTER BELL and the fact that JIMMY HOFFA should pay for BELL's trial expenses because BELL "did it for him".

On 5/28/63, and 6/6/63, information re TONY PROVENZANO and WALTER GLOCKNER Murder, NY 72-164, NK 72-58. On 5/28/63, NOONAN in discussing the then current TONY PROVENZANO trial and the GLOCKNER murder, remarked that whoever did the murder, was not a friend of TONY PRO's and that it never should have happened while PRO was on trial. It was informant's opinion that NOONAN was not so much referring to the fact that a man was murdered but that the timing of the murder was inappropriate for TONY PRO.

On 6/6/63, NOONAN, FUREY, GLEASON and two unknown individuals discussed the TONY PRO trial and the murder of GLOCKNER. NOONAN remarked that he was "in Hoboken that day when it happened and got told by somebody that he was in that car". This was in answer to a remark by one of the two unknown individuals to the effect that "he's been identified being in the car --- him and a fellow by the name of WALSH, (sounds
