NY 3778-C* advised that there was no activity on 11/13 and 11/14/63.

On 11/15/63, informant advised that CONNIE NOONAN and AUSTIN FURZY held a generally non-pertinent conversation concerning TEDDY GLEASON. However, at one point NOONAN remarked that GLEASON never tells the truth anymore when it comes to money. There was no additional information of value obtained on that date.

There was no pertinent activity on 11/16 to 11/18/63, inclusive. The information obtained on 11/19/63, has been furnished to the Bureau by airtel dated 11/23/63. There was no pertinent activity from 11/20 to 12/3/63. It is noted that during this period on 11/26/63, the informant advised that NOONAN remarked that he had been sick for ten days.

Apparently FUREY's son is employed by a company whose employees are represented by Local 1730 of the ILA. NY 1716-C, who is very familiar with Local 1730, ILA, has been alerted to determine the identity of the company for which FUREY's son works. The informant advised there was no additional information received on that date.

There was no pertinent activity on 12/14 or 12/15/63.

On 12/16/63, informant advised that NOONAN and GLEASON were in NOONAN's office and NOONAN referred to an individual who apparently is located in the headquarters of the ILA on the nineteenth floor as a "very bad individual". This individual apparently is seeking some sort of favor from GLEASON and NOONAN and while neither are desirous of granting this favor, they are reluctant to refuse this individual because they are afraid of him. The informant was unable to identify this individual at this time.

There was no activity on 12/17/63.

On 12/18/63, the informant advised that there were two individuals in NOONAN's office with NOONAN and FUREY. One of these individuals was possibly named "Red" GIBSON(ph). GIBSON and the other unknown individual had been discharged from a trucking company because they were allegedly caught pilfering from one of the cartons on the platform of the trucking company.

NOONAN and FUREY discussed with these individuals the fact that the security guard at this trucking company had apparently surprised GIBSON and the other unknown individual in the act of pilfering. The guard had ordered them to put back the pilfered objects and went looking for a Mr. WALSH

by PCI [redacted] who is employed at this trucking company. It has been further determined that because of the discharge of GIBSON and the unknown subject, the Continental Trucking Co. has been struck by Local 1730, ILA.

OTHER 4

There was no activity from 12/19 to 12/29/63.

A copy of this airtel is being designated for 15-0 insofar as this matter is still being considered by the USA's Office, EDNY for prosecution.

A copy of this airtel plus a copy of the 12/7/62 airtel which furnished information concerning the obtaining of Christmas presents by NOONAN, FURBY and GLEASON is being furnished for 122-NEW. It is felt that the information furnished in the 12/7/62 airtel plus the information furnished in the instant airtel indicates a pattern of long standing by NOONAN, FURBY and GLEASON of taking Christmas presents from employers whose employees are represented by Local 1730.

The NYO will attempt to properly evaluate information furnished by NY 3778-C* and the Bureau will be kept immediately advised of all pertinent activities concerning this informant.
