ANGELO BRUNO, AKA; AR. DAILY RAD. PH 623-C* REPORTED ON A CONTROVERSY BETWEEN IGNATIUS DENARO AND FRANK MONTE AND FRANK NARDUCCI APPARENTLY CONCERNING DENARO'S MOVE TO DECLARE HIMSELF IN AS PARTNER OF ZIGANETTE GAME BEING "BANKROLLED" BY SONNY RICCOBENE. INFORMANT INDICATES THAT DENARO UNKNOWN TO BRUNO AND GOING OVER THE HEAD OF BRUNO HAD GONE TO NEW YORK TO SEE A MEMBER OF THE "COMMISSION." SEVERAL CONVERSATIONS BETWEEN BRUNO AND OTHERS NOT YET IDENTIFIED REQUIRE CLARIFICATION AND INTERPRETATION. BRUNO HAS NOT YET FORMULATED WHAT ACTION HE WILL TAKE AS THE OFFICIAL REPRESENTATIVE OF THE "COMMISSION."

PH 614-C-TE HAS NO DIRECT KNOWLEDGE OF PRESENT FRICTION BUT HAS REPORTED DENARO'S ACTIONS DECLARING HIMSELF AS PARTNER AS WELL AS FRANK D'ALPHONSO, MARIO "SONNY" RICCOBENE'S OFFICE MAN, REPORTING THE FIRST FRICTION. PCI [REDACTED] REPORTS WORKING AT BRUNO'S NUMBERS RELAY POINT IN UPPER DARBY, A SUBURB OF PHILADELPHIA, IN WHICH NUMBERS WERE CALLED TO THIS POINT TO [REDACTED] AND THEN RELAYED BY ANOTHER INDIVIDUAL WORKING WITH [REDACTED] TO ANOTHER LOCATION, MOST LIKELY THE BANK. [REDACTED] REPORTING DAILY INFORMATION.
