In connection with Bruno's numbers operation, you should be very alert to the possibility of developing a substantive violation under one of our antigambling statutes. This matter should be given your continuous attention and all logical investigation surrounding Bruno's numbers operation should be completed as soon as possible.

In the event your investigation does not substantiate a prosecutable Federal violation, information developed should be furnished directly and personally to Philadelphia Police Commissioner Albert Brown for his use in bringing Bruno and the employees in this gambling network to justice.

Promptly furnish to the Bureau all information available to you concerning Denaro's alleged difficulties with Bruno. Also advise whether the individual Denaro was allegedly contacting in New York has been identified.

NOTE: Philadelphia has placed a Top Echelon informant in Bruno's numbers racket at Philadelphia. This informant is furnishing information concerning the entire operation to the Philadelphia Office on a daily basis. It would appear this information should definitely result in prosecution of Bruno and/or his associates for either a violation of the Federal antigambling laws or antigambling laws of Pennsylvania.
