On 12/12/60 SU 432-C furnished information that since PETE LICAVOLI (Detroit and Phoenix Top Hoodlum) was released from Federal Prison in September, 1960, ROSELLI has been "pushing" and attempting to throw his weight around in the Las Vegas area whenever he, ROSELLI, was in Las Vegas. Informant was unable to ascertain what, if any, connection there exists between ROSELLI and LICAVOLI. Informant stated that he had received information that during the week of 12/5-9/60 ROSELLI attempted to "throw his weight" around at the Riviera Hotel in Las Vegas, and, as a result, he received a severe beating, which resulted in his broken leg. Informant was unable to ascertain at this time who administered the beating, but he will attempt to do so.

On 12/19/60 LA 4129-C furnished information that ROSELLI had visited Perino's Restaurant during the latter part of the week, 12/11-17/60, and informant received the impression that ROSELLI was living at his apartment on Crescent Heights Boulevard. On 12/19/60 a pretext telephone call was made to Roselli's apartment, and a man answered the telephone.

In view of the above facts, it is possible that ROSELLI may be spending some time in Los Angeles and will probably be living at his apartment on Crescent Heights Boulevard.

The Los Angeles Office contemplates conducting fisurs of ROSELLI, and in order to do so in the neighborhood where he resides, it is imperative that a fixed observation be utilized.

Apartment Number 2 at 1242 North Crescent Heights Boulevard (the same apartment which was previously rented in connection with this investigation) is available for rental at a monthly rate of \$200.00.

Bureau authority is requested for rental of the above apartment for a period of one month.
