ANTI-RACKETEERING

Reference is made to the report of Special Agent JAMES B. FANNING, Pittsburgh, dated May 20, 1963.

There follows a brief characterization of informants used in referenced report.

PG T-32 is a business man in Mercer County, Pa., who has a life-time association with gamblers and racketeers; who will not testify and who has furnished reliable information in the past.

PG T-35 is an individual who has worked in numerous racket setups in Westmoreland and Allegheny Counties, both Pennsylvania; who will not testify and who has furnished reliable information in the past.

PG T-39 is a gambler and club operator in Pittsburgh, Pa.; who will not testify and who has furnished reliable information in the past.

PG T-38 is an individual who has been connected with gambling activities in the New Kensington, Pa., area for almost fifteen years; who will not testify and who has furnished reliable information in the past.

MM T-2 is an individual who mingles with criminal elements on a daily basis in the Miami, Florida, area; who will not testify and who has furnished reliable information in the past.
